CERTIFICATE OF SURFACE WATER RIGHT

(In accordance with the provisions of Chapter 117, Laws of Washington for 1917, and amendments thereto, and the rules and regulations of the Department of Water Resources thereunder.)

This is to certify that MILL A SCHOOL DISTRICT NO. 31 of SKAMANIA COUNTY
of Cook, State of Washington, has made
proof to the satisfaction of the Department of Water Resources of Washington, of a right to the use
of the waters of an unnamed spring, a tributary of -,
with point or points of diversion within the Lot 4, Block 5, Plat of Manzanola Orchard Tracts
Sec. 10, Twp. 3 N., R. 9 E., W. M., under and subject to provisions contained in
Appropriation Permit No. 14831 issued by the Department of Water Resources, and
that said right to the use of said waters has been perfected in accordance with the laws of Washington,
and is hereby confirmed by the Department of Water Resources of Washington and entered of
record in Volume 22, at Page 10545, on the 27th day of November, 19 68
that the priority date of the right hereby confirmed is February 21, 1967; that the
amount of water under the right hereby confirmed, for the following purposes is limited to an amount
actually beneficially used and shall not exceed 0.02 cubic foot per second, 5 acre-feet per
year continuously during the entire year for domestic supply for school for 150 persons.

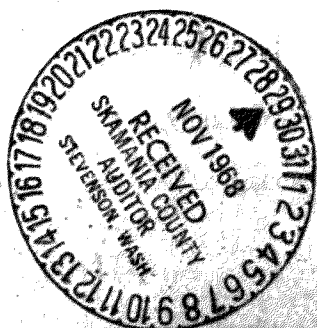
A description of the lands under such right to which the water right is appurtenant, and the
place where such water is put to beneficial use, is as follows:


NW $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$ and W $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Sec. 11, T. 3 N., R. 9 E.W.M.; EXCEPT that part of said
NW $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$ lying southwesterly of a straight line described as beginning 316 feet north
and ending 441 feet east, of the southwest corner of said NW $\frac{1}{4}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$; AND EXCEPT roads.

This right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of
use ~~as~~ described, except as provided in Sections 6 and 7, Chapter 122, Laws of 1929.

This certificate of surface water right is specifically subject to relinquishment for nonuse of water
as provided in Section 18, Chapter 233, Laws of 1967.
