## AGREEMENT RESPECTING RIGHT TO USE PUBLIC WATERS OF THE STATE OF WASHINGTON

57035

WHEREAS, pursuant to a permit to appropriate public waters of the State of Washington issued to Pacific Power & Light Company ("Pacific"), on April 24, 1956, by the State of Washington Department of Conservation and Development, the State Supervisor of Water Resources on September 7, 1960 issued to Pacific a Certificate of Surface Water Right, Certificate Record No. 16, Page no.7890, which said permit and certificate relate to the diversion and use of the waters of the North Fork of the Lewis River for power purposes in connection with the Swift Hydroelectric Project, the point or points of diversion being within the South half of the Northwest quarter  $(S_2^1NW_4^1)$  and the North half of the Southwest quarter  $(N_2^1SW_4^1)$  of Section 28, Township 7 North, Range 5 East, W.M., Skemania County, and the place where such water is put to beneficial use being described in said certificate as:

## Swift No. 1 Plant

Lots 4 and 5 of Section 28, Township 7 North Range 5 East, W.M., Skamania County

## Swift No. 2 Plant

Lot 1 of Section 25, Township 7 North, Range 4
East, W.M., Cowlitz County

WHEREAS, on October 29, 1956, the Federal Power Commission granted Pacific a license for Swift Plant No. 1, Project No. 2111, and on November 29, 1956, granted a license for Swift Plant No. 2, Project No. 2213 to Public Utility District No. 1 of Cowlitz County, Washington, ("District"); and

WHEREAS, on June 4, 1957, Pacific and the District entered into a power contract whereby they agreed in part that the District should have the right to use the regulated flow of the Lewis River and impounded water of Pacific's reservoir as released from the operation of Swift Plant No. 1

and that Pacific should discharge such waters so released into the District's canal leading to Swift Plant No.2;

NOW, THEREFORE, in consideration of the premises and pursuant to the rights granted to Pacific by virtue of said permit and certificate, Pacific hereby confirms to the District the right to such use of said waters as released from Swift Plant No.1 by receiving the same at the afterbay of said Swift Plant No.1 and by discharging the same from Swift Plant No.2 in Lot 1, in Section 25, Township 7 North, Range 4 East, W.M. and the District agrees that any water so received and used in Swift Plant No.2 shall be discharged below Swift Plant No.2 for return to said Lewis River pursuant to said Certificate of Surface Water Right.

It is understood that the foregoing shall not in any way supercede or modify any agreements presently in effect between Pacific and the District.
