KNOW ALL MEN BY THESE PRESENTS, That Frank L. ROYCE, Executor of the Estate of Pauline Laurent

do hereby make, constituted and appointed, and by these presents do make, constitute and appoint BERNARD J. HEAVEY JR. his true and lawful attorney for him and in his name, place and stead and for his use and benefit.

to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever, as are now or shall hereafter become due, owing, payable or belonging to him, as Executor of the Estate of Pauline Laurent, and have, use and take all lawful ways and means in his name, or otherwise, for the recovery thereof, by attachments, arrest, distress or otherwise, and to compromise and agree for the same, and to make, sign, seal and deliver acquittances, or other sufficient discharges for the same; for him and in his name, to bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments, and accept the seizin and possession of all lands, and all deeds, and other assurances in the law therefor; and to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and hereditaments, upon such terms and conditions and under such covenants as he shall think fit; to sign and transfer any note or mortgage; to dedicate any street, avenue, alley, place, way or park for public uses.
