

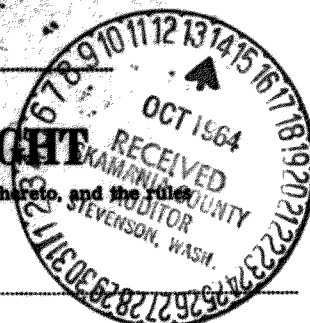

CERTIFICATE OF SURFACE WATER RIGHT

(In accordance with the provisions of Chapter 117, Laws of Washington for 1917, and amendments thereto, and the rules and regulations of the State Supervisor of Water Resources thereunder.)



This is to certify that ERNEST G. SWIGERT

of Washougal, State of Washington, has made
 proof to the satisfaction of the State Supervisor of Water Resources of Washington, of a right to the use
 of the waters of Unnamed Spring, a tributary of Columbia River,
 with point or points of diversion within the NE 1/4 NW 1/4
 Sec. 11, Twp. 1 N., R. 5 E., W. M., under and subject to provisions contained in
 appropriation Permit No. 13548 issued by the State Supervisor of Water Resources, and
 that said right to the use of said waters has been perfected in accordance with the laws of Washington,
 and is hereby confirmed by the State Supervisor of Water Resources of Washington and entered of
 record in Volume 19, at Page 9200, on the 12 day of October, 1964,
 that the priority date of the right hereby confirmed is November 4, 1963; that the
 amount of water under the right hereby confirmed, for the following purposes is limited to an amount
 actually beneficially used and shall not exceed 0.05 cubic feet per second during entire year
 for domestic supply for 5 homes; and 0.05 cubic feet per second for swimming pool.

A description of the lands under such right to which the water right is appurtenant, and the
 place where such water is put to beneficial use, is as follows:


Commencing at a point 190 feet north of meander corner of section line between Sections 11 and 12, T. 1 N., R. 5 E. W. M., said point being initial point of survey and being the south line of the right-of-way of the S.P. & S. Railway; thence along the said line south 68°24' west paralleling the center line of said S.P. & S. Railway 100 feet distant 490 feet. Thence south 43° west 200 feet; thence south 15°30' east 150 feet; thence following the meander line of river as follows: South 77°30' east 99 feet; north 77°15' east 99 feet. East 132 feet, north 6°45' east 99 feet, north 63°30' east 198 feet, north 10° west 92.4 feet, south 80°30' east 52.4 feet to the meander corner above described; thence north along section line 190 feet to initial point and place of beginning.

A tract of land located in Gov't Lots 3 and 4 in Sec. 11, T. 1 N., R. 5 E. W. M., described as follows: Beginning at a point on the southerly boundary of the Spokane Portland and Seattle Railway right-of-way 40 feet distant from the northwest corner of a tract of land conveyed to Rena G. Swigert by deed dated September 17, 1918, and recorded at Page 563 of Book Q of Deeds, Records of Skamania County, Washington; thence in a southwesterly direction following the southerly boundary of said railroad right-of-way to the easterly line of a tract of land conveyed to D. McPherson by deed dated March 18, 1905, and recorded at Page 116 of Book I of Deeds; thence south 46°15' east along the east line of said McPherson tract to intersection with the meander line of the Columbia River; thence northeasterly following the meander line of the Columbia River to a point 40 feet distant from the southwest corner of the said Swigert tract; thence northerly along a line 40 feet distant from and parallel to the westerly line of the said Swigert tract to the point of beginning.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described, except as provided in Sections 6 and 7, Chapter 122, Laws of 1929.
