## Stanton W.Stryker to United States

This indenture made the 30th day of August in the year of our Lord One thousand nine hundred and six, between Stanto W. Stryker and Ella M. Stryker his wife of the City of Portland, County of Multnoman and State of O. egon, patties of the first part, and the United States of America, party of the second part, witnesseth: Whereas the said Stanton W.Stryker on the 28th.d.y of July 1904 made cash entry No. 6912 under the act of congress June 3,1878 and amended August 4,1890, being for the sale of timber land, for the Northwest quarter of the North est quarter of Section thirteen and the East half of the Northeast quarter and the Southwest quarter of the Northeast quarter of section Fourteen in Township two North Range six east of the Willamette Meridian, in Skamania County, State of Washington, in the Vancouver, Washington, Land District, and whereas on the 4th.day of February 1905, a patent issued by the Government to the said Stanton W.Stryker for a tract of land in part erroneous and not the land applied for in said Cash Entry No. 6912, to-wit: for the Northwest quarter of the Northwest quarter of Section thirteen and the East half of the Northeast quarter and the Southwest quarter of the Northeast quarter of Section fourteen, in Township Two North, Range Six East of the Willamette Meridian.' The said parties of the first part for and in consideration of the act of Courses June 3,1878 and other valuable considerations by them received by the Government do by these presents radisc, rilegrand for ever quitchalm to the United States of America and its assigns, all the following described lands, erroneously described in the above mentioned patent, to-wit: the Southwest quarter and the Northwest quarter of the Northeast quarter of Section fourteen in Township Two North of Range six East of the Willamette Meridian.

To have and to hold, all and singular the said premises, together with the appurtenances, unto the said party of the second part and its assigns forever.
