This Indenture made the 1st day of March in the year of our Lord one thousand nine hundred and eleven by and between J.Solomon and Rose Solomon his wife each of the County of Multnomah, State of Oregon, the parties of the first part and Albert I.Loeb of the city and of the County of San Francisco State of California, the party of the second part, witnesseth, that the said parties of the first part for and in consideration of the sum of fifteen thousand (\$15,000.00) dollars lawful money of the United State of America to them in hand paid by the said party of the second part the receipt whereof is hereby acknowledged do by these presents grant, bargain, sell convey and confirm unto the said party of the second part his heirs and assigns forever all those certain lots pieces or parcels of land situate lying and being in the county of Skamania State of Washington particularly described as follows, to-wit:
