

ORDINANCE VACATING THE PUBLIC STREET KNOWN AND

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF STEVENSON:

SECTION I.

That a petition signed by H. E. Rogers has been regularly filed with the Town Clerk seeking the vacation of the public street known and designated as Dollar Avenue as the same appears on the plat of the Subdivision of Lot 8 of Stevenson Park Addition on file and of record at page 70 of Book 8 of Plate, Records of Skamania County, Washington; that the said H. E. Rogers is the owner of all the real property abutting upon the said street.

SECTION II.

That Dollar Avenue above described be and hereby is vacated after public hearing held in accordance with Section 35.70.030 of the Revised Code of Washington.

SECTION III.

That this Ordinance shall be in full force and effect forthwith and on publication hereof.

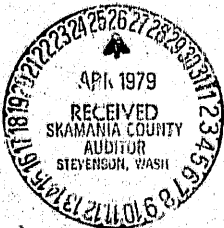
