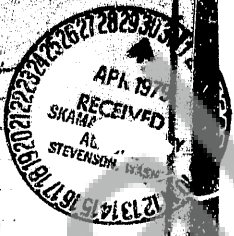

KNOW ALL MEN BY THESE PRESENTS, That *James A. Anderson*



do hereby make, constitute and appoint, and by these presents do make, constitute and appoint

James A. Anderson

my true and lawful attorney for *M.L.* and in *M.L.* name, place and stead and for *M.L.* use and benefit

to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands what ever, as are now or shall hereafter become due, owing, payable or belonging to *M.L.*

and here, say and take all lawful ways and means in *M.L.* name or otherwise, for the recovery thereof, by attachments, arrest, distress or otherwise, and to compromise and agree for the same, and to make, sign, seal and deliver acquittances, or other sufficient discharges for the same for *M.L.* and in *M.L.* name

to bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments, and accept the same and possession of all lands, and all deeds, and other assurances in the law thereof: and to lease, let, demise, bargain, sell, release, release, convey, mortgage and hypothecate lands, tenements and hereditaments, upon such terms and conditions

and under such covenants as *M.L.* shall think fit to assign and transfer any note or mortgage to dedicate any street, avenue, alley, place, way or park for public use, ALSO to bargain and agree for, buy, sell, mortgage, hypothecate, and in any and every way and manner deal in and with goods, wares and merchandise, choses in action and other property, in possession or in action, and to release mortgages on lands or chattels, and to make, do and transact all and every kind of business of what nature and kind soever, AND also for *M.L.* and in *M.L.* name

and as *M.L.* act and deed, to sign, seal, execute, deliver and acknowledge such deeds, leases and assignments of lands, tenements, hereditaments, agreements, mortgages, hypothecations, bills of lading, bills, bonds, notes, receipts, evidence of debt, releases and satisfactions of mortgage, judgment and other debts, and such other instruments in writing, of whatsoever kind or nature, as may be necessary or proper in the premises:

GIVING AND GRANTING unto *M.L.* said attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises as fully to all intents and purposes as *M.L.* might or could do if personally present:
