SPECIFIC DEVISE AND BEQUEST

I hereby give, devise and bequeath all of the property of which I may die possessed, whether real, personal or mixed, of whatsoever kind or nature, and wheresoever situate, unto my beloved wife, MAXINE FRANCES BUECHELE, as her sole and separate property, should she survive me by more than ninety days. In the event my wife and I should die simultaneously or I should not survive her by more than ninety days, then I give, devise, and bequeath all the property of which I may die possessed of whatever nature and kind and wheresoever situate to my wife's children, my step-children, ROBERT RAYFIFLD WIESTER and GARY LEE WIESTER, share and share alike, per stirpes.

In the event that I shall survive my wife by more than ninety days then such amount of my property as represents the property bequeathed to me by my wife, MAXINE FRANCES BUECHELE, as determined by the inventory and appraisal which shall have been filed with the Department of Revenue Estate Tax division, for the State of Washington, I devise and bequeath to ROBERT RAYFIELD WIESTER and GARY LEE WIESTER, share and share alike, per stirpes.

RESIDUARY ESTATE
