The West one half ($W\frac{1}{2}$) of the Southwest quarter (S.W. $\frac{1}{4}$) of Section three (3) and Lots numbered Six (6) and Seven (7) of Section Four (4) in Township three (3) North of Range Nine (9) East of the Willamette Meridian,containing One hundred and fifty seven and twenty four hundredths (157.24)acres,together with all and singular the tenements,hereditaments and appurtenances thereto belonging or in anywise appertaining and all of our right title and interest in and to the above described premises and each and every part and parcel thereof.To Have and to Hold the same unto the said Richard E.McLean,Trustee and to his successors and assigns forever.And the said Grantors above named do hereby covenant with the said grantee his successors and assigns that at the date hereof we are well seized in fee simple of the premises above conveyed and we will and our heirs,executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whomsoever.
