Know all Men by these presents that we, Owen Mathews and Margaret Mathews his wife of The Dalles, of the County of Wasco in the State of Oregon, for and in consideration of the sum of Sixteen Hundred and no/100 Dollars to us in hand paid by Richard E. McLean, Trustee, of Wells Township, of the County of Delta, State of Michigan, the receipt whereof is hereby acknowledged have granted, bargained and sold and by these presents do grant, bargain, sell and convey unto the said Richard E. McLeanⁿ, Trustee, and to his successors and assigns forever, all of that certain tract of land lying and being in the County of Skamania State of Washington and particularly described as follows, to-wit:

The South one half (S $\frac{1}{2}$) of the Southeast quarter (S.E. $\frac{1}{4}$) of Section Six (6) and the North one half of the Northeast quarter (N.E. $\frac{1}{4}$) of Section Seven (7) Township three (3) North of Range Nine (9) East of the Willamette Meridian, containing one hundred and sixty (160) acres, together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining and all of our right title and interest of, in or to the above described premises and each and every part and parcel thereof. To Have and to Hold, the same unto the said Richard E. McLean, Trustee and to his successors and assigns forever. And the said grantors above named do hereby covenant to and with the said grantee his successors and assigns that at the date hereof we are well seized in fee simple of the premises above conveyed and we will and our heirs and executors and administrators shall warrant and defend the title thereto against the lawful claims or demands of any person or persons whatsoever.
