Together with, all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining and also all our estate, right title and interest in and to the same, including dower and claim of dower. To Have and to Hold the above described and granted premises unto the said Jennie K.Hilton and unto her heirs and assigns forever. And we, W.M.Kollock and Maud Kollock, George C.Kollock and Alice Kollock, the grantors above named, do covenant to and with Jennie K.Hilton the above named grantee, her heirs and assigns, that the above granted premises are free from all incumbrances and that we will and our heirs, executors and administrators shall warrant and forever defend the above granted premises against the lawful claims and demands of all persons whomsoever.
