Judgment and Decree of Appropriation.

The Court having entered heretofore an order of appropriation in the above entitled cause, and having directed that the damages sustained by the claimants above named be ascertained, and the petitioner above named and the claimants Oregon Railroad and Navigation Company, Cascade Railroad Company, Farmers Loan & Trust Company, New York Security & Trust Company, The New York Trust Company and the State of Washington, being all of the claimants who have appeared herein, having agreed in writing as to the amount of damages sustained herein by said claimants lasteabove mentioned by reason of the appropriation of the premises described in said order of apprpriation:

It is now Ordered, Adjudged and Decreed that, by reason of the appropriation and use of the ## land, real estate and premises of the Claimants Oregon Railroad & Navigation Company, Cascade Railroad Company, Farmers Loan & Trust Company, New York Security & Trust Company, and the New York Trust Company hereinafter described, for any and all of the corporate purposes of petitioner, said last named claimants will be damaged in the sum of Ten Thousand Dollars by the taking and injuriously affecting said land, real estate and premises, irrespective of any benefits from any improvements proposed by said petitioner, Portland and Seattle Railway Company; and It is further order, Adjudged and Decreed that, by reason of the appropriation and use of the land, real estate and premises of the State of Washington hereinafter described, for any and all the corporate purposes of petitioner, said claimant the State of Washington will be damaged in the sum of Fifty Dollars by the taking and injuriously affecting said land, real estate and premises, irrespective of any benefits from any improvements proposed by said petitioner, Portland and Seattle Railway Company. And it further appeareing that none of the other claimants to this proceeding, will be damaged by the appropriation of the premises hereinafter described said petitioner either having made sufficient compensation to the said other claimants or it appeareing that said other claimants are in no wise damaged by the appropriation of the premises hereinafter described: It is Ordered, Adjudged and Decreed that the Claimants Oregon Railroad & Navigation Company, Cascade Railroad Company, Farmers Loan & Trust Company, New York Security & Trust Company, And the new York Trust Company have and recover from the petitioner, Portland and Seattle Railway Company, the sum of \$10,000.00, for the taking and injuriously affecting said land, real estate and premises; and It is further Ordered, Adjudged and Decreed that the claimant the State of Washington have and recover from
