Kraft to Adams

This Indenture made this 12th day of December 1910 between Mathew Kraft a single man of Stevenson Washington, party of the first part, and Netta Adams of White Salmon Washington, party of the second part, witnesseth:

That the said party of the first part for and in consideration of the sum of one hundred and no/100 dollars (\$100.00) to him in hand paid by the said party of the second part the receipt whereof is hereby confessed and acknowledged does by these presents grant, bargain, sell and convey unto the said party of the second part and to her heirs and assigns the following described real estate situated in Skamania County Washington to-wit:

Lot numbered two (2) of Strawberry Hill Tracts (in section thirty-six township three North Range seven and one half east Willamette Meridian) according to the official plat thereof filed and of record in the office of the County Auditor of Skamania County Washington. Together with all and singular the tenements hereditaments and appurtenances thereto belonging. This conveyance is intended as a mortgage to secure the payment of the sum of one hundred dollars (\$100.00) lawful money of the United States, together with interest thereon at the rate of six per cent per annum from date until paid according to the terms of one promissory note made by Mathew Kraft Dated December 13th 1910 payable on or before one year after date, to the order of Netta Adams, and these presents shall be void if such payment be made according to the terms and conditions thereof, but in case default shall be made in the payment of the
