Quit Claim deed from C.R.Bell to C.C.Brown.

THIS INDENTURE, made this 5 day of June in the year of our Lord one thousand nine hundred and-----BETWEEN C.R.BELL of Castle Rock, Washington the party of the first part and C. C. Brown of Castle Rock, Washington for St. Helens Amalgamated Group Mining Claims, the party of the second part:

WITNESSETH, That the said party of the first part, for and in consideration of the sum of --- -----one and no 00 (\$1.00)-----Dollars gold coin of the United States of America, to me in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents remise, release and forever quit-claim unto the said party of the second part and to his heirs and assigns the following described Quartz Lode, Esmarelda Claim No. I North situated in St. Helens Mining District, State of Wash., County of Skamania and described as follows; Beginning at a post marked No. I twenty-five (25) linear feet South of Discovery post situated about two hundred (200) feet up a deep canyon from its mouth, about one-fourth ($\frac{1}{4}$) mile North of the middle Toutle River from a point three and one half ($3\frac{1}{2}$) miles down said river from the outlet of Spirit Lake, and about four miles North from the West shoulder of Mt. St. Helens; running thence three hundred (300) linear feet West to a post marked "Post No. 2"; thence fifteen hundred (1500) linear feet North to a point marked "Post No. 3"; thence six hundred (600) linear feet East to a post marked "Post No. 5"; passing at three hundred (300) linear feet to a post marked "Post No. 4" indicating center of Lode; thence fifteen hundred (1500) linear feet South to a post marked "Post No. 6 "; thence three hundred (300) linear feet West to place of beginning Directions Magnetic. Also Quartz Lode Esmarelda Claim No. I South and described as follows: Beginning at a post marked No. I twenty-five (25) linear feet North of Discovery Post.
