This Indenture made this 1st day of June 1911 between C. Miller a bachelor of Stevenson Washington, party of the first part and the Trustees of Stevenson Aerie number 1744 Fraternal Order of Eagles a fraternal coporation of Stevenson Washington, party of the second part witnesseth: That the said party of the first part for and in consideration of the sum of three hundred fifty and no/100 dollars (\$350.00) lawful money of the United States to him in hand paid the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell and convey unto the said party of the second part and to its successors and assigns the following described tract or parcel of land lying being and situated in the county of Skamania state of Washington to-wit: Lots numbered nine (9) and four (4) in Section thirty six (36) of township three (3) North of range seven and one half (7½) East of W.M. The east half of the Northeast quarter of the Northeast quarter of section thirty six (36) Township three (3) North of Range seven (7) East of W.M. Together with all and singular the tenements hereditaments and appurtenances thereto belonging.
