This Indenture made this sixth day of June 1911 between May E. Breslin of Portland, Oregon, party of the first part and A. W. Lambert, Agent, party of the second part, Witnesseth:

That the said party of the first part for and in consideration of the sum of eighteen hundred fifty and no/100 dollars to her in hand paid the receipt whereof is hereby acknowledged have bargained and sold and by these presents does bargain, sell alien release convey and confirm unto the said party of the second part his heirs and assigns forever all of the following described parcel of real estate situated in the County of Skamania state of Washington to-wit:

The southeast quarter of the Northwest quarter and the Northeast quarter of the Southwest quarter of Section four in Township one North of Range five East of W.M. containing 80 acres. Together with the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining and also all the estate right title and interest of said party of the first part of in and to the same. To have and to hold the herein before granted bargained and described premises with the appurtenances unto the said party of the second part his heirs and assigns forever. This conveyance is intended as a mortgage to secure the payment of the sum of eighteen hundred fifty and no/100 dollars in accordance with the terms of a certain promissory note of which the following is a copy to-wit:
