having instructed the jury upon the law, the jury retired to consider their verdict. And the jury heving thereafter agreed upon a verdict returned with the same into the court. And the jury by their verdict having made an assessment of the damage which shall result to the claimants by reason of the appropriation and use of the lands, real estate and premises, described in the petition herein, by petitioner for any and all of its corporate uses and having ascertained, determined and awarded the amount of damages to be paid said owners for the taking and injuriously affecting such land, call estate and premises for the purpose of such enterprise, irrespective of any benefit from any improvements proposed by said petitioner. And said verdivt having been in the sum of Fifty-Five Dellars it is ordered and adjudged by the Court that the claimants pred. C. Yettick and Hattie Yettick hid wife, have and recover of and from the petitioner portland and Seattle Railway Company, the sum of Fifty-Five Dellars for the taking and injuriously affecting their said lands, real estate and premises, irrespective of any benefits from any improvements proposed by said petitioner, portland and Seattle Railway Company. And said petitioner having paid the amount of said judgment into court for the benefit of said claimants,

It Is Ordered/Adjudged and Decreed by the Court that the following described real estate in Skamania County, Washington, be and the same is hereby apprepriated to the use of petitioner for any and all of its corporate purposes and the legal title thereto is hereby vested in said corporation for any and all of its said corporate purposes. The following is the description of the property above referred to and hereby apprepriated:

A strip of land fifty feet in width in the southwest quarter of the Northeast quarter ef section 34, township 2 north of range 6 eas: of Willamette Meridian, lying immediately adjacent to and parallel with the northerly boundary line of the right of way of the portland and seattle Railway Company as now located and in course of construction across said land, and extending from the center line of said section 34 in a northeasterly direction a distance of two hundred and fifty feet, measured along the said northerly boundary line of said right of way.

Also a strip of land twenty five feet in width lying immediately adjacent to and parallel with the said northerly boundary line of the right of way of the portland and Seattle Railway Company as now located and incourse of construction across said premises and extending from a point two hundred and fifty feet northeasterly from the center line of said section 34, measured along said northerly boundary line of said right of way, a distance of two hundred and seventy feet more or less, to the east line of said southwest quarter of the Northeast quarter of said section 34. Also all that part of the Southwest quarter of the Northeast quarter of said section 34 lying south of the said right of way, the whole amount of land above described and appropriated amounting to one and three tenths acros.
