Lewis Eyman to A.R. Gangloff

This Indenture made this the 18th day of December A.D. 1906 by and between Lewis Eyman and Harriett C. Eyman his wife, of Carson, Washington, hereinafter called the grantors, and Anthony R. Gangloff of Portland, Oregon, hereinafter called the grantee, Witnesseth, That the said grantors for and in consideration of the lawful sum of Six Thousand (\$6000.00) Dollars received of the said grantee, the receipt whereof is hereby acknowledged do hereby grant, bargain, sell and convey unto the grantee and unto his heirs and assigns that certain real property with the appurtenances tenements hereditaments and privileges situated in the County of Skamania and State of Washington and described as follows, to-wit:

Those parts of Section numbered seventeen (17) Township three (3) North, Range eight (8) East of Willamette Meridian, described as follows: Southwest quarter of Southwest quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of said section, and the South half of the Northwest quarter of the Southwest quarter (S $\frac{1}{2}$ of NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of said Section, and the Southeast quarter of the Southwest quarter of said section and a strip of land two (2) rods wide, extending along the entire south line of Northeast quarter of Southwest quarter of said section; excepting however one square acre in Southeast corner of said Southwest quarter Section, containing exclusive of said exception One Hundred (100) acres according to Government survey.
