THIS INDENTURE, Made this 10th day of December, 1906, BETWEEN, Richard E. McLean of the Township of Wells, Delta County, Michigan, party of the first part, and Wesley E. Wells and Charles W. Kates, of the same place of residence, John H. Haak of Haakwood, Cheboygan County, Michigan, and Frank D. Mead of the City of Escanaba, Michigan, parties of the second part: WHEREAS, by several deeds of recent date, all of which have been recorded in the Auditor's office for Skamania County, Washington, Robert C. Wilson, James E. Taylor, Joel W. Koontz, Owen Matthews, D. Siddall, B.S. Huntington, Trustee, Charles J. Stubling, Annie C. Stubling, Rollen I. Young, Greenbury C. Eshelman, David C. Wigle, Alterius W. Giesy, Henry H. Kibbey, John B. Meyers and Joseph Rosslow conveyed to the said party of the first part as trustee, all those certain parcels of land situated in the said county of Skamania, in the State of Washington, described as follows, to wit:
