County of Multnomah State of Oregon in consideration of Thirten hundred (\$1300.00) Dollars to us paid by Carrie Jackson of Skamania County, State, of Washington, , have gargained and sold and by these preents do grant, bargain, sell and convey unto the said carrie Jackson her, heirs and assigns all the following bounded and described real property situated in the County of Skamania State of Washington: All that tract and procel of land, the northeast corner of which is situated at a point thirty (30) feet south of a point, two hundred eight and seven tenths (208.70 feet west of the Northeast corner of Lot nine (9) Section One (I) Township two (2) North Range seven East Willamette Meridian, thence south two hundred and thirty six (236) feet, thence west two hundred and one and three tenths (201.3) feet, thence North two hundred and thirty six (236) feet, thence East two hundred and one and three tenths (201.3) feet to the place of beginning excepting a strip of land sixteen (16) feet wide running east and west through the center of said tract which is hereby reserved for an alley. Udell his wife, grantors above named do covenant to and with Carrie Jackson the above named grantee her hiers and assigns that we are lawfully seized in fee simple of the above granted premises that the above granted premises are free from all incumbrances and that we will and our heirs, executors and administrators shall warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever.
