Wash., party of the second part does by these presents remise, release and quitclaim unto said party of the second part his heirs and assigns, all interest of the said party of the first part in and to the following described real property situated in Skamania Co. Wash, to-wit:

Beginning at a point 130 feet west of the Northeast corner of the Northwest quarter of the North east quarter of Sec. 29 Tp. 3 North Range 8 east of the W.M., thence south 225 feet, thence west 447½ feet, thence south to the intersection of the south line of said quarter, thence west along said south line to the southwest corner, thence north to the Northwest corner, thence east to point of beginning; provided that the party of the first part hereby expressly reserves the right to use water from said land, and the right to take, convey or carry water across, upon or over said land herein granted shall remain in the said party of the first part, her heirs and assigns forever.
