thence along said road to place of beginning, containing I5 acres more or less; excepting the following which is reserved a strip 60 feet wide commencing at a point on the west side of said land 488 feet north of south line, thence running S.74 deg.E.across said land, also a a strip 20 feet wide on both east and west side of said land north of said 60 feet strip of land, said strips being reserved for roads. The Grantors also grant to grantee the right to lay inch pipe to a certain spring on land owned by grantors adjoining said land.
