

Clara H.Carpenter to Savage & Lapham.

This Indenture, Made this 15th day of April in the year of our Lord one thousand nine hundred and seven, Between Clara H.Carpenter as Administratrix of the estate of E.F.Carpenter, deceased, and in her own right as widow of said E.F.Carpenter, deceased, the party of the first part, and Erastus Savage of Oregon and A.H.Lapham of Lewis County, Washington, Witnesseth:

That the said parties of the first part, for and in consideration of the sum of One Dollar lawful money of the United States, to her in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged does by these presents remise, release and forever quitclaim unto the said parties of the second part and to their heirs and assigns, the following described tracts, lots or parcels of land, situated, lying and being in the County of Skamania, State of Washington and particularly bounded and described as follows, to-wit: The Mining claims called the Myrh No.1 and Myrh No.2, the notice of Location of the Myrh No.1 is recorded in the Auditors office of said Skamania County in Book #C# Mineral Locations page 286, and the notice of location the the Myrh No.2 in said Book #C# page 287; also the same mining claims, amended notice of which said Myrh No.1 under the name Myrrh No.1 is recorded in said Auditors office in said Book #C# page 299 and amended notice of location of which said Myrh No.2 is recorded in said Auditors office in said Book #C# page 299 under the name of Myrrh No.2. The said notices of location are made a part of this deed for the particular description of said mining claims and all particulars therein contained. This conveyance is for the purpose of removing all question of doubt of title in the parties of the second part. Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise paaertaining and ther eversion and reversions, remainder and remainders, rents, issues and profits thereof. To Have and to Hold all and singular the said premises together with the appurtenances unto said parties of the second part and to their heirs and assigns forever.
