

Marble to Freehafer ✓

Know all men by these presents that Guy Marble of Council Idaho, party of the first part for and in consideration of the sum of two hundred dollars lawful money of the United States to him in hand paid by W.E. Freehafer of Council, Adams County Idaho second part, the receipt whereof is hereby acknowledged does by these presents grant, bargain, sell and assigns and set over unto said party of the second part his heirs and assigns the portion of interest herein described in a certain indenture of mortgage bearing date the 7th day of August 1911 made and executed by Frank E. Bethea and Mattie Bethea husband and wife to the said party of the first part and recorded in the office of the County Recorder of the County of Skamania State of Washington in Book K of Mortgages at page 243 on the 10th day of August 1911. Together with the first promissory note in said mortgage described being for the sum of \$200.00 of even date with said mortgage bearing interest at 6% per annum and due July 1st 1912 with the interest due and to grow due thereon and when said note and interest are paid according to the tenor thereof then all interest of said second party in said mortgage cease.
