Porter the the following-described real estate, situated in the County of Skamania, State of Washington, to-wit: The SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec.30; also a piece of land described as follows: Beginning at the NW corner of the NE $\frac{1}{4}$ of NE $\frac{1}{4}$ of said Sec.30, running thence South 80 rods, thence East 80 rods, thence in a northwest direction on a straight line to place of beginning, being a triangular piece, all in Sec.30. Tp.3 N. R. 8 E.W.M., containing 60 acres. Also all the timber now standing or fallen on the balance of my homestead, to-wit: The W $\frac{1}{2}$ of NW $\frac{1}{4}$ of Sec. 29, and the E $\frac{1}{2}$ of NE $\frac{1}{4}$ of Sec.30, all in Township three North Range eight E..W.M., said timber to be removed within 10 years from date of this instrument and if not removed within said time, then to revert back to grantors herein.
