Sly to Arnold

This Indenture made this eleventh day of December 1911 between Raymond C. Sly and Theo S. Sly his wife parties of the first part and W.A. Arnold party of the second part, Witnesseth: That the said parties of the first part for and in consideration of the sum of four hundred fifty and no/100 dollars lawful money of the United States to them in hand paid by the said party of the second part the receipt whereof is hereby acknowledged do by these presents grant bargain, sell and convey unto said party of the second part his heirs and assigns the following described tract or parcel of land situate lying and being in the County of Skamania State of Washington and bounded and described as follows to-wit:

Commencing at the southeast corner of Lot numbered eight (8) of Stevenson Park Addition according to the official plat thereof filed by R.C. Sly and duly recorded on page 30 of plat Nook A records of Skamania County Washington, thence northwesterly along the east line of said lot numbered eight (8) to the intersection thereof with the east side of Kanaka Creek Cut off road as the said road is now surveyed, located and established across said lot numbered eight (8) thence southerly along east side
