

location monument No.1 bears north one degree and twenty-four minutes west two thousand one hundred and forty-nine and ninety-eight hundredths feet distant, and the corner to said townships nine and ten, bears south seventy-six degrees and twenty-two minutes and thirty seconds west eight hundred and two and forty-eight hundredths feet distant. Thence, first course, north eighty-eight degrees and twenty-eight minutes east three hundred feet to a point from which discovery post bears north one degree and thirty-two minutes west six feet distant; five hundred and seventy-three and six tenths feet to witness corner to corner No.2, a cedar post six inches square, four feet long, marked W.C.2-781 A; W.C.1.781 A; W.C.1-781 A and W.C.4-781 A; six hundred feet to corner No.2, not established. Thence, second course, north one degree and thirty-two minutes west one thousand four hundred and thirty-five and one tenth feet to corner No.3, a larch post six inches square four feet long, marked 3-781 A. and 4-781 A. Thence, third course, south eighty-eight degrees and twenty-eight minutes west six hundred feet to corner No.4, identical with corner No.1 of said America No.1 lode claim. Thence, fourth course, south one degree and thirty-two minutes east one thousand four hundred and thirty-five and one tenth feet to corner No.1, the place of beginning; the survey of the lode claim as above described extending one thousand four hundred and thirty-five and one tenth feet in length along said America No. 2 vein or lode.

Beginning for the description of the America No.3 lode claim at corner No.1, identical with corner No.1 of said America No.2 lode claim. Thence, first course, south one degree and thirty-two minutes east one thousand five hundred feet to corner No.2, a larch post six inches square, four feet long, marked 2-781 A. 4-781 A., 3-781 A. and 3-781 A. Thence, second course, north eighty-eight degrees and twenty-eight minutes east three hundred feet to a point from which discovery post bears north one degree and thirty-two minutes west four feet distant; six hundred feet to corner No.3, a larch post six inches square, four feet long, marked 3-781 A., 2-781 A., 4-781 A and 3-781 A. Thence, third course, north one degree and thirty-two minutes west one thousand four hundred and twenty-four and seven tenths feet to witness corner to corner No.4, a larch post six inches square, four feet long, marked W.C.4-781 A., W.C.1-781 A., W.C.1-781 A. and W.C.2-781 A., one thousand five hundred feet to corner No.4, not established. Thence, fourth course, south eighty-eight degrees and twenty-eight minutes west six hundred feet to corner No.1 the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said America No.3 vein or lode.

Beginning for the description of the America No.4 lode claim at corner No.1, a larch post six inches square, four feet long, marked 9-781 A. and 2-781 A. from which the east quarter corner of section one, in township nine north of range five east, Willamette Meridian bears north seventy-nine degrees and thirty-six minutes west eight hundred and sixty-two and thirty-nine hundredths feet distant, and U.S.location monument No.7 bears south twenty-nine degrees, thirteen minutes and thirty seconds west four thousand one hundred and ninety-eight and one tenth feet distant. Thence, first course, north eighty-eight degrees and twenty-eight minutes east six hundred feet to corner No.2, a fir post six inches square, four feet long marked 2-781 A and 1-781 A. Thence, second course, north one degree and thirty-two minutes west one thousand five hundred feet to corner No.3, identical with corner No.3 of said America No.3 lode claim. Thence, third course, south eighty-eight degrees and twenty-eight minutes west three hundred feet to a point from which discovery post bears south one degree and thirty-two minutes east eight feet distant; six hundred feet to corner No.4, identical with corner No.2 of said America No.3 lode claim. Thence, fourth course, south one degree and thirty-two minutes east one thousand five hundred feet to corner No.1, the
