Beginning for the description of the Wilson lode claim at corner No.1, identical with corner No. 2 of said America No.1 lode claim, from which the corner to said townships nine and ten, bears south thirty-seven degrees and seventeen minutes west two thousand and fiftyseven and six tenths feet distant. Thence, first course, north eighty-eight degrees and twenty-eight minutes east ninety-five feet to corner No. 3 of said America No. 2 lode claim; two hundred and fifty feet to a point from which discovery post bears north seven degress and twenty-seven minutes west ten feet distant; five hundred and twenty-two and six tenths feet to corner No.2, a larch post six inches square, four feet long, marked 2-781 A. Thence second course, north seven degrees and twenty-seven minutes west seven hundred and twenty-three and six-tenths feet to corner No.3, a larch post six inches square, four feet long, marked 3-781 A.
