Beginning for the description of the Marchland lode claim at corner No.1, identical with corner No.4 of said America No.3 lode claim, not established, from which the corner to said townships nine and ten bears south eighty-one degrees, thirty-two minutes and forty seconds west one thousand three hundred and ninety-four and seven tenths feet distant, and said U.S. location monument No. 1 bears north seventeen degrees west two thousand two hundred and thirty and seventy-six hundredths feet distant. Thence, first course, south one degree and thirty-two minutes east seventy-five and three tenths feet to said witness corner, one thousand five hundred feet to corner No.2, identical with corner No.3 of said America No.3 lode claim. Thence, second course, north eighty-eight degrees and twenty-eight minutes east three hundred feet to a point from which discovery post bears north one degree and thirty-two minutes west two and five tenths feet distant; six hundred feet to corner No.3, a larch post six inches square, four feet long, marked 3-781A and 3-781 A. Thence third course, north one degree and thirty-two minutes west one thousand five hundred feet to corner No.4, identical with corner No.2 of said Alderman Peak lode claim. Thence, fourth course, south eighty-eight degrees and twenty-eight minutes west six hundred feet to corner No.1, the place of beginning the survey of the lode claim as above described extending one thousand five hundred feet in length along said Marchland vein or lode.

Beginning for the description of the Prince lode claim at corner No.1 identical with corner No.2 of said America No.4 lode claim, from which said U.S. location monument No.7 bears south thirty-five degrees and forty-five minutes west four thousand five hundred and thirty-four and five tenths feet distant, and the east quarter corner of said section one bears north eighty-four degrees, twenty-nine minutes and thirty-five seconds west one thousand four hundred and fifty-four and seventy-eight hundredths feet distant. Thence, first course, north eighty-eight degrees and twenty-eight minutes east six hundred feet to corner No.2, a fir post six inches square, four feet long, marked 2-781 A. Thence, second course, north one degree and thirty-two minutes west one thousand five hundred feet to corner No.3, identical with corner No.3 of said Marchand lode claim. Thence, third course, south eighty-eight degrees and twenty-eight minutes west three hundred feet to a point from which discovery post bears south one degree and thirty-two minutes east fourteen feet distant; six hundred feet to corner No.4, identical with corner No.3 of said America No.3 lode claim. Thence, fourth course, south one degree and thirty-two minutes east one thousand five hundred feet to corner No.1, the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said Prince vein or lode.

Beginning for the description of the Wayne lode claim at corner No.1, a larch post six inches square, four feet long, marked 1-781 A and 2-781 A., from which said U.S. Location monument No.1 bears north eighteen degrees and thirty-one minutes east one thousand seven hundred and sixty-four and twenty-six hundredths feet distant, and the corner to said townships nine and ten bears south fourteen degrees and five minutes west six hundred and eighty-six and two
