Beginning for the description of the Mamie lode claim at corner No.1, identical with corner No.4 of said Baby Barnes lode claim, from which the corner to said townships nine and ten, bears north twenty-four degrees and forty-eight minutes east nine hundred and thirty-six and forty-eight hundredths feet distant. Thence, first course, north one degree and thirty-two minutes west one thousand five hundred feet to corner No.2, identical with corner No.4,
