Thence, fourth course, north eighty-eight degrees and twenty-eight minutes east six hundred feet to corner No.1, the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said Mabel vein or lode.

Beginning for the description of the Ada lode claim at corner No.1, identical with corner No.4 of said Mabel lode claim, from which the east quarter corner of said section one, bears south fifty degrees and six minutes east four hundred and seventy-four and eighty-nine hundredths feet distant. Thence, first course, north one degree and thirty-two minutes west one thousand five hundred feet to corner No.2, identical with corner No.4 of said Baby Barnes lode claim. Thence, fourth course, north eighty-eight degrees and twenty-eight minutes east six hundred feet to corner No.1, the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said Ada vein or lode.

Beginning for the description of the Linnie lode claim at corner No.1, identical with corner No.4 of said Ada lode claim, from which the east quarter corner of said section one, bears south seventy-three degrees and twenty minutes east one thousand and six and fourteen hundredths feet distant, and said U.S. location monument No.7 bears south three degrees eighteen minutes and thirty seconds west four thousand one hundred and fifteen feet distant.
