

south eighty-eight degrees and twenty-eight minutes west three hundred feet to a point from which discovery post bears south one degree and thirty-two minutes east ten feet distant; six hundred feet to corner No.3, a larch post six inches square, four feet long, marked 3-781 A and 2-781 A. Thence, third course, south one degree and thirty-two minutes east one thousand five hundred feet to corner No.4, a larch post six inches square, four feet long, marked 4-781 A and 1-781 A. Thence fourth course, north eighty-eight degrees and twenty-eight minutes east six hundred feet to corner No.1, the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said Linnie vein or lode.

Beginning for the description of the Inez lode claim at corner No.1, identical claim, from which the east quarter corner of said section one bears south eighty degrees and seven minutes east one thousand five hundred and eighty-seven and sixty-eight hundredths feet distant, and said U.S. location monument No.7, bears south five degrees, three minutes and forty seconds east four thousand one hundred and eight and two tenths feet distant. Thence, first course, north one degree and thirty-two minutes west one thousand five hundred feet to corner No.2, identical with corner No.3 of said Linnie lode claim. Thence, second course south eighty-eight degrees and twenty-eight minutes west three hundred feet to a point from which discovery post bears south one degree and thirty-two minutes east four feet distant; six hundred feet to corner No.3, a larch post six inches square, four feet long, marked 3-781 A. Thence, third course, south one degree and thirty-two minutes east one thousand and five hundred feet to corner No.4, a larch post six inches square, four feet long, marked 4-781 A. Thence, fourth course, north eighty-eight degrees and twenty-eight minutes east six hundred feet to corner No.1, the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said Inez vein or lode.

Beginning for the description of the Cena lode claim at corner No.1, a fir post six inches square, four feet long, marked 1-781 A, situate on bank of Spirit Lake and on line 4-1 of said Linnie lode claim, from which the east quarter corner of said section one, bears south seventy-eight degrees and three minutes east one thousand three hundred and forty-seven and nine tenths feet distant. Thence first course, south eighty-eight degrees and twenty-eight minutes west two hundred and forty-five feet to corner No.4 of said Linnie lode claim and corner No.1 of said Inez lode claim; three hundred and fifty-eight feet to a point from which discovery post bears south thirty-one degrees and thirty-five minutes west eight and five tenths feet distant; seven hundred and sixteen feet to corner No 2, a larch post six inches square, four feet long, marked 2-781 A. Thence, second course, south thirty-one degrees and thirty-five minutes west one thousand five hundred feet to corner No.3, a fir post six inches square four feet long, marked 3-781 A. Thence, third course, north eighty-eight degrees and twenty-eight minutes east five hundred and seventeen and seven tenths feet to corner No.4, a cedar post six inches square, four feet long, marked 4-781 A. on Lake shore from which said U.S. location monument No.7 bears south twenty-one degrees and twenty-two minutes east three thousand and twenty-three and three tenths feet distant. Thence, fourth course, north fourteen degrees and twenty-four minutes east two hundred and forty-nine and eight tenths feet to corner No.5, a fir post six inches square, four feet long, marked 5-781 A. on Lake shore. Thence, fifth course, north eighty-eight degrees and twenty-eight minutes east two hundred and eighty-six and six tenths feet to corner No.6, on stone point, x and 6-781 A. marked on rock on side of x. Thence, sixth course, north twenty-one degrees and fifteen minutes east five hundred and seventy-one feet to corner No.7, a fir post six inches square, four feet long, marked 7-781 A. Thence, seventh course, north forty-nine degrees and forty-seven minutes east three hundred and twenty-seven and seven tenths feet to corner
