

bears south twenty-four degrees and five minutes and thirty seconds west one thousand two hundred and eighty-five and six tenths feet distant, and the corner common to sections one and twelve, in township nine north of range five east, and sections six and seven, in township nine north of range six east, Willamette Meridian, bears south eighty-nine degrees and thirty-two minutes east six hundred and sixty-one and eighttenths feet distant.

Thence, first course, north fourteen degrees and thirty-three minutes east one thousand five hundred feet to corner No.2, a larch post six inches square, four feet long, marked 2-781 A.

Thence, second course, south eighty-eight degrees and twenty-eight minutes west twenty-four and four tenths feet to corner No.3 of said Earl lode claim, and corner No.6 of said Lakeside lode claim; four hundred and thirty-seven and two tenths feet to witness corner to corner No.3, identical with witness corner to corner No.5 of said Lakeside lode claim; four hundred and ninety-two and thirty-four hundredths feet to corner No.3, not established.

Thence, south eighteen degrees and forty-seven minutes west three hundred and thirty-two feet to point on rock in crevice. Thence, south twenty-six degrees and seven minutes west three hundred and fifteen and nine tenths feet to point on rock in crevice. Thence, south twenty-two degrees and fifty nine minutes west two hundred and twelve and two tenths feet to point on rock in crevice. Thence, south eighteen degrees and nine minutes west one hundred and thirty-six and six tenths feet to point in crevice of rock. Thence, south six degrees and thirty-one minutes west five hundred and thirty-three and five tenths feet to corner No.4, at a point on gravel against perpendicular rock and not established. Thence, fourth course, north eighty-eight degrees and twenty-eight minutes East sixty-six feet to witness corner to said corner No.4, a larch post six inches square, four feet long, marked W.C. 4-781 A. and W.C.2-781 A.; two hundred and thirty-five and two tenths feet to a point from which discovery post bears north fourteen degrees and thirty-three minutes east five feet distant; five hundred and forty-seven and four tenths feet to corner No.1, the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said Hillside vein or lode.

Beginning for the description of The Falls lode claim at corner No.1, a hemlock post six inches square, four feet long, marked 1-781 A. from which corner No.1 of said Hillside lode claim bears north eighty-eight degrees and twenty-eight minutes east twenty-four and four tenths feet distant, and said section corner bears south eighty-nine degrees and thirty six minutes east six hundred and eighty-six and seventeen hundredths feet distant. Thence, firsts course south eighty eight degrees and twenty eight minuts west three hundred feet to a point from which discovery post bears south four degrees and three minuts east eleven feet distant, four hundred and fifty seven feet to witness corner to corner No.2, identical with witness corner No.4 of said Hillside lode claim, five hundred and twenty three feet to corner No.2 on lake shore. Thence south six degrees and thirty one minuts west four hundred and seventeen and five tenths feet to point on shore and not established. Thence south thirteen degrees and twenty four minuts east three hundred and seventy one and one tenths feet to point on shore. Thence south four degrees and three minuts west four hundred and fourteen and five tenths feet to point on gravel bed at Harmony point at mouth of creek, from which said U.S. Location monument No.7 bears north forty four degrees and thirty four minutes east twenty three and two tenths feet distant. Thence south twenty nine degrees and fifty four minuts east three hundred and sixty seven and twenty six hundredths feet to corner No.3 on gravel bank and not established. Thence third course, north eighty eight degrees and twenty eight minuts east eight feet to witness corner to said corner No.3 a larch post six inches square four feet long marked W.C.3-781 A, and W.C.2-781 A, four hundred and thirty nine and seven tenths feet to corner No.4, a larch post six inches square four feet long marked 4-781 A. Thence fourth course
