This Indenture made this sixteenth day of pecember 1911 between A.S. Ellis and Edna C Ellis his wife, and L.D. Snyder and Nellie Snyder his wife of Multhomah County State of Oregon, the parties of the first part, and S.A. Swanson of Raymond Washington, the party of the second part Witnesseth: That the said parties of the first part for and in consideration of the sum of four thousand (\$4000.00) dollars gold coin of the I Unitted States to them in hand paild, the reipt whereof is hereby acknowledged have granted bargained and policy and by these presents do grant, bargain, sell and convey unto the said party of the second part the following described premises to-wit: The Southwest quarter for the Southwest quarter of section twenty-nine (29); the north west quarter of the Northwest quarter of section thirty two (32), the south one half of the Morthwest quarter and the north one half of the Southwest quarter of section thirty two (32); Lot numbered two (2) of section thorty-two (32); the north half of the northeast Auarter of section this ty one (31) and the south one half of the Southeast, quarter of section thirty (30) all in Township three (3) North of Range nine (9) East of Willamette Meridian in Skamania County Washington; together with all and singlar the tenements heredtiaments and appurtenances thereunto belonging and the rents issues and profits thereof. To have and to hold the said premises with the appurtenances unto the said S.A. Swanson his heirs and assigns for ever. This conveyance is intended as a mortgage to secure the payment of two certain promissory notes of even date herewith ; one in the principal sum of two thousand dollars due on or before one year after date at Raymond, Washington with interest from date until paid at the rate of seven per cent per annum until paid; and one in the principal sum of two thousand dollars due one or before eighteen months after date at Raymond Washington with interst thereon from date until paid at the rate of seven per cent per annum. And the parties of the first part covenant and agree to and with the said party of the sec nd part his heirs and assigns that it is hereby made a condition of this mortgage that said first parties will not cut more then three million feet of timber from the lands herein described until the first note described above and which is due the 16th day of December 1912, shall have been paid in full together with the iterest thereon.
