WE, GERALD DILLEY and BARBARA DILLEY, husband and wife, grantors, being owners of the following described premises:

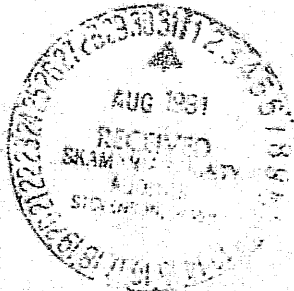

for valuable consideration do hereby grant to WILLIAM SMITH, grantee, for a period of five (5) years from the date hereof, the right to the use of water from a well on the above-described premises provided such water is used only for personal, non-commercial purposes on the following described premises:

Lots 5 and 6 of Washougal Summer Home Tracts, according to the official plat thereof on file and of record in Book A of Plats at page 78 in the office of the Auditor of Skamania County, Washington, in Section 31, Township 2 North, Range 5 East of the Willamette Meridian.

and further provided that grantee shall be solely responsible for the maintenance and repair of any system of transporting the water from grantor's premises, and also provided that grantee shall be responsible for complying with any health or safety laws regarding said water transportation system and shall permit nothing to be done which would result in the contamination of said well.

This grant is of water rights only for a period of five (5) years and shall not be construed as granting

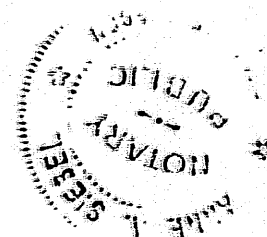
