Beginning at a point nine hundred and thirty feet (930) West of the Northeast corner of the Northwest quarter of the Northeast quarter of Section twenty-nine (29) Township three North of Range eight (8) East of Will. Mer., thence running One hundred feet (100) south, thence One Hundred (100) feet West, thence One Hundred (100) Feet North, thence One Hundred Feet (100) East to point of beginning, all lying and being in Skamania Co. Washington. And the said grantor also grants to the said grantee the right to take and use water from an undeveloped spring, situated about one hundred (100) feet south of the tract of land herein granted. And the said grantor hereby expressly reserves the right to take and carry water across the tract of land hereby granted.
