Mosher to Fallert

This Indenture made this twenty first day of February 1911 between C.N. Mosher and Emma Mosher his wife, parties of the first part and B. Fallert party of the second part Witnesseth: That the said parties of the first part for and in consideration of the sum of one hundred and fifty dollars lawful money of the United States to us in hand paid by the said party of the second part the receipt whereof is hereby acknowledged does by these presents grant, abagain, sell and convey unto the said party of the second part and to his heirs and assigns the following described tract or parcel of land lying and being in the county of Skamania state of Washington to-wit:

Lot (10) ten in Block No. (2) two, also Lots (8) and (9) eight and nine on Block No. (2) two all of Boyd's and Wilkinson's addition to the Town of Carson Washington as shown by the recorded plat thereof at Stevenson Washington, together with all and singular the tenements hereditaments and appurtenances thereunto belonging. This conveyance is intended as a mortgage to secure the payment of one hundred and fifty (\$150.00) dollars lawful money of the United States together with interest thereon at rate of 8 per cent per annum from date until paid according to the terms and conditions of some certain promissory note bearing date February 21st 1911 and made by C.N. Mosher and Emma Mosher payable on or before six months after date to the order of B. Fallert and these presents shall be void if such payment be made according to the terms and conditions thereof. But in case default shall be made in the payment of the principal or interest of said promissory note or any part thereof when the same shall be due and payable according to the terms and conditions thereof then the said party of the
