Harry Hazard to P. & S. Ry. Co.

The Grantors for and in consideration of the sum of One Dollar, in hand paid, convey and warrant to the Portland and Seattle Railway Company, a Washington corporation, its successors and assigns the following described real estate situate in the County of Skamania, State of Washington, to-wit: a strip of land forty feet in width in the Shepard Donation Land claim in section thirty six, township three North of Range seven and one half east of the Willamette Meridian, described as follows: Being 20 feet on each side of the following described center line of Co. Road: Beginning at a point on the northern boundary of the Portland and Seattle Ry. Co.'s right of way as the same is now located and being constructed, the said point being 100 feet and at right angle to Station 1662 plus 05 to the north; thence 60 feet north 50° 05' west, thence 120 feet north 28° 15' west thence 108 feet north 62° 13' west, thence 43 feet south 71° 07' west to boundary of present Co.
