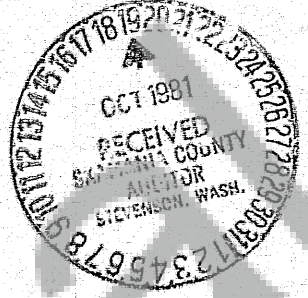

The court further orders:

1) The equity of \$23,630.74 in the family residence located at .006 Ryman Cemetery Road, Carson, Washington 98610 is awarded 1/2 to Petitioner and 1/2 to Respondent. Said 1/2 belonging to Petitioner shall be paid forthwith or bear seven (7%) percent interest per annum until paid.

2) The equity of \$13,100.00 in the land more legally described
