## LEGAL DESCRIPTION OF PROPERTY ON WHICH WATER IS TO BE USED

A tract of land located in the SW<sub>1/4</sub> of Section 27, T. 2 N., R. 6 E.W.M.: Beginning at the southwest corner of Section 27, T. 2 N., R. 6 E.W.M.; thence north 01°05'09" east 2290.16 feet along the west line of said Section 27; thence south 89°08'43" east 882.50 feet to the true point of beginning; thence south 89°08'43" east 511.10 feet to the point which bears north 01°05'09" east 2295.32 feet and south 88°55'59" east 1393.58 feet from the southwest corner of said Section 27, said point being on the centerline of Road "B"; thence southerly along the centerline of Road "B" to a point which bears 01°05'09" east 1375.60 feet and south 88°55'59" east 1295.03 feet from the southwest corner of said Section 27, said point being the point of intersection of the centerlines of Road "A" and Road "B"; thence westerly along the centerline of Road "A" to a point which bears north 01°05'09" east 1293.63 feet and south 88°55'59" east 1083.75 feet from the southwest corner of said Section 27, said point being the point of intersection of the centerlines of Road "A" and Road "C"; thence northwesterly along the centerline of Road "C" to a point which bears south 01°05'09" west 862.38 feet from the true point of beginning; thence north 01°05'09" east 302.30 feet; thence north 43°54'51" west 141.42 feet; thence north 46°05'08" east 141.42 feet to a point which bears south 01°05'09" west 360.08 feet from the true point of beginning; thence north 01°05'09" east 360.08 feet to the true point of beginning; containing 10.0 acres, more or less.



## PROVISIONS

Diversion intake shall be tightly screened at all times with wire mesh having openings with dimensions not greater than 0.125 (1/8) inch.

The Water Resources Act of 1971 specifies certain criteria regarding utilization and management of the waters of the State in the best public interest. Issuance of this certificate was based on sufficient waters available, at least during portions of the year. However, it is pointed out to the certificate holder that his use of the water may be subject to regulation at certain times, based on the necessity to maintain water quantities sufficient for preservation of the natural environment.
