

LAST WILL AND TESTAMENT

OF

EARNEST FRED METZGER

KNOW ALL MEN BY THESE PRESENTS:

That I, EARNEST FRED METZGER, being of sound mind and memory, do make and publish this, my Last Will and Testament. I do declare that any previous wills, testaments, or codicils that I may have made are set aside and superseded by this Will.

I.

I do declare that I have no children, I have not had children. I am a bacholer and I have only one living close relative, that is my sister, LOUISE M. BENNETT, who is not in need of any portion of my estate and I do not leave anything to my sister.

II.

Immediately upon my death, I hereby direct that my personal representative, hereinafter named, arrange for a modest interment and thereafter pay the expenses of that interment and pay any and all just and due debts that may have been incurred in my behalf.

III.

I hereby give, devise, and bequeath all of my property of whatsoever nature and wheresoever located to Western Washington Chapter of the Arthritis Foundation.

IV.

In addition to the property that I jointly hold with my sister and the accounts that are in my name, I am the owner of 1/2 interest of a substantial savings account which has been maintained by my sister, LOUISE M. BENNETT. My sister has, over the course of the last year, promised that she would transfer my 1/2

interest in that account to an account in my name. To this point I have received no evidence of any such transfer and I do direct that the personal representative of my estate recover my share of any funds held at my death by my above-named sister. I hold no rancor against my sister. I do believe that she has taken advantage of the fact that I am incapacitated to the extent that I am not able to leave my home and take care of my own affairs and that any failure on her part to transfer 1/2 of our previously jointly held funds to my own individual is a contractual matter with her and that my personal representative should pursue that share of my estate.

I nominate and appoint WILMA FOSTER as the personal representative of this, my Last Will and Testament, and I direct that she shall serve as such without bond or other undertaking being required of her and without the intervention of any Court, except as may be absolutely necessary under the non-intervention provisions of the state in which I may leave my estate.

IN WITNESS WHEREOF, I have hereunto set my hand to this, my Last Will and Testament, this 26 day of April, 1982.
