It is therefore ordered by the court that the estate of Hazel Nichols, deceased and the estate of Hazel Nichols deceased and of Barney Haffey, are each hereby decreed to be settled and closed up and the said H.E.Prindle the administrator of each of said estates is gereby fully discharged and his bondsmen released from further liabilities.

It is further ordered, adjudged and decreed by the court that the said Daniel Nichols and Louise nichols be and they are hereby decreed to be the heirs of the said Hazel Nichols, deceased, and they are hereby decreed to be the owners of the Southeast quarter of Section 5 Township 6 Past of the Willamette Meridian, in Skamania County, State of Washington, in common and undivided.

It is further ordered that a certified copy of this order be filed for record with the Auditor of said Skamania County, Washington.
