Centerline Description

Beginning at Engineer's Station 0+00, said point lying S 27° 11' 20" W, 83.60 feet from the northeast corner of the northwest quarter of Section 2, Township 3 North, Range 10 East W.M.; thence S 28° 13' 01" W 196.34 feet to P.C. 1+96.34 being the P.C. of a 124.56 foot radius curve to the left, thence following said curve through a central angle of 52° 05' 25" 113.24 feet; thence S 23° 52' 24" E 65.47 feet to P.C. 3+75.04 being the P.C. of a 40.75 foot radius curve to the left; thence following said curve through a central angle of 19° 20' 33" 138.16 feet; thence S 43° 12' 57" E 30.48 feet to P.C. 5+43.70 being the P.C. of a 75.39 foot radius curve to the right; thence following said curve through a central angle of 106° 28' 33" 140.10 feet; thence S 63° 15' 36" W 206.17 feet to P.C. 8+89.96 being the P.C. of a 351.97 foot radius curve to the right; thence following said curve through a central angle of 14° 57' 50" 91.92 feet; thence S 78° 13' 26" W 59.16 feet to P.C. 10+41.04 being the P.C. of a 154.57 foot radius curve to the right; thence following said curve through a central angle of 49° 09' 30" 132.62 feet to P.T. 11+73.66, said point lying S 27° 45' 14" W 998.47 feet from the northeast corner of the northwest quarter of Section 2, Township 3 North, Range 10 East, W.M.
