Sheriff of Skamania County to Frank Aldrich.

Know all men by these presents: That Whereas by virtue of a certain execution issued out of the Superior Court of the State of Washington for the County of Skmania, holding terms at Stevenson in said County on the 25th day of April 1906 in favor of Frederick Daubrock and against Fred B. Barnes, Henrietta A. Barnes and P.F. Inman on a certain judgment rendered in said Court on the 9th day of January 1906 and directed and delivered to me as Sheriff of Skamania County, commanding me of the goods and chattels and tenements of the said Fred B. Barnes Henrietta Barnes and P.F. Inman to make certain moneys in said writ mentioned, I, James Haffey Sheriff as aforesaid, did, upon the 25th day of April 1906 levy on and seize all the estate, right, title and interest with the said Defendants Fred B. Barnes, Henrietta Barnes and P.F. Inman on said day had of, in and to the premises hereinafter described; and on the 9th day of June 1906 within the hours prescribed by law, to-wit: At the hour of two O'clock P.M., sold said premises at public auction in the County of Skamania at the door of the Court House thereof, having first given due and legal notice of the time and place of sale and whereas at said sale the said premises were stricken off to Frank Aldrich for the sum of eight hundred and ninety eight and 85/100 Dollars, he being the highest bidder therefor, and that being the highest bid for the same, and, whereas on the 9th day of July 1907 the said Superior Court by an order duly made and entered confirmed said sale, and whereas the time allowed by law for redemption of said property has expired without such redemption having been made;

Now Therefore, in consideration of the premises aforesaid and of the payment of the said sum of eight hundred and ninety eight & 85/100 Dollars, the receipt whereof is hereby acknowledged, I, James Haffey, Sheriff as afore said, have Granted, Sold, Conveyed and Confirmed and by these presents do Grant, Sell, convey and Confirm unto the said Frank Aldrich all of the estate, right, title and interest which the said Fred B Barnes, Henrietta Barnes and P.F Inman had on the said 9th day of June 1906 or at any time thereafter, in and to the following described premises, to-wit: The Southwest quarter of Section twenty-two (22) in Township three (3) North of Range nine (9) East of Willamette Meridian in Skamania County, Washington. To have and to hold the same unto the said party of the second part, his heirs and assigns forever; as fully and completely as the said party of the first part can by virtue of the premises convey the same.
