An Undivided half ($\frac{1}{2}$) of the South half of the Northwest quarter, the Northeast quarter of the Northwest quarter and the Southwest quarter of the Northeast quarter of Section twenty-seven (27) in Township two (2) North of Range six (6) East of Willamette Meridian, containing one hundred and sixty acres, the intention being to convey and quitclaim an undivided half of said tract of 160 acres.

To Have and to Hold the same, together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining to the said Rudolph Koch and to his heirs and assigns forever.
