

GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS that I, NINA MAE BACON, currently residing in Kitsap County, Washington, have made, constituted and appointed, and by these presents do make, constitute and appoint BARBARA M. BEHM, whose mailing address is Post Office Box 236, Silverdale, Kitsap County, Washington, as my true and lawful attorney for me and in my name, place and stead and for my use and benefit to ask, demand, sue for, recover, collect and receive all such sums of money, debts, dues, accounts, legacies, bequests, interests, dividends, annuities and demands whatsoever, as are now or shall hereafter become due, owing, payable or belonging to me and have, use and take all lawful ways and means in my name, or otherwise, for the recovery thereof, by attachments, arrest, distress or otherwise, and to compromise and agree for the same, and to make, sign, seal and deliver acquittances, or other sufficient discharges for the same; for me and in my name, to bargain, contract, agree for, purchase, receive and take lands, tenements, hereditaments, and accept the seisin and possession of all lands, and all deeds, and other assurances in the law therefore; and to lease, let, demise, bargain, sell, remise, release, convey, mortgage and hypothecate lands, tenements and hereditaments, upon such terms and conditions and under such covenants as said BARBARA M. BEHM shall think fit, to assign and transfer any note or mortgage; to dedicate any street, avenue, alley, place way or park for public uses. ALSO to bargain and agree for, buy, sell, mortgage, hypothecate, and in any and every way and manner deal in and with goods, wares, and merchandise, choses in action and other property, in possession or in action, and to release mortgages on lands or chattels, and to make, do and transact all and every kind of business of what nature and kind soever. AND ALSO for me and in my name and as my act and deed, to sign, seal, execute, deliver and acknowledge such deeds, leases and assignments of leases, covenants, indentures, agreements, mortgages, hypothecations, bottomries, charter parties, bills, bonds, notes, receipts, evidences of debt, release and satisfactions of mortgages, judgments and other debts, and such other instruments in writing, of whatsoever kind or nature, as may be necessary or proper in the premises; if BARBARA M. BEHM is unable or unwilling to act as attorney in fact, I then do make, constitute and appoint RICHARD B. BACON to act as attorney in fact with all powers granted herein.

GIVING AND GRANTING UNTO my said attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises as fully to all intents and purposes as I might or could do if personally present; hereby ratifying and confirming all that my said attorney shall lawfully do or cause to be done, by virtue of these presents.

This General Power of Attorney is not intended to be revocable by me. In the event I become incompetent it is to be followed by a durable power of attorney in favor of Barbara M. Behm. The only basis upon which the document can be revoked is due to an appointment of a guardian of my person and estate.

I am giving this power of attorney to my daughter BARBARA M. BEHM whom I trust implicitly to act for my best interest and welfare.



I have executed this document freely and voluntarily and have intentionally revoked the power of attorney I was talked into signing by John Bacon and Jim Bacon, my youngest sons.
