Whereas, The said Earl L. Irwin has this day sold to the said Mrs.S.S.Irwin the following described property in Skamania County, Washington, to-wit: A one third interest in Ninety Seven (97) acres more or less of land situated in Sec.six (6) Tp. one (1) North of Range Six (6) East W.M. The other two thirds of this same property being owned by Ord L. Irwin and Pearl L. Walker, for the sum of Seven Hundred and Fifty Dollars, (\$750.00) with interest at the rate of Five per cent per annum to be paid in United States Gold Coin, or its equivalent, in yearly installments, as follows: Two and 50/100 Dollars (\$2.50) on the delivery of this bond, the receipt of which is hereby acknowledged, and One Hundred and Fifty Dollars (\$150.00) on the First day of each and every year thereafter until the whole sum is paid, and the failure for twenty days to make any payment after the same shall become due shall render this bond null and void, and all payments thereon shall be forfeited.
