Thence, second course, south eighty-six degrees and fifty-five minutes cast three hundred feet to a point from which discovery post bears north three degrees and five minutes east fifteen feet distant; six hundred feet to corner No.3, identical with corner No.3 of said Index No.9 lode claim.

Thence, first course, north eighty-six degrees and fifty-five minutes west three hundred feet to a point from which discovery beras south three degrees and five minutes west twelve feet distant; six hundred feet to corner No.2, identical with corner No.3 of said Index No.9 lode claim.

thence, second course, south three degrees and five minutes west one thousand five hundred feet to corner No.3, identical with corner No.2 of said Index No.9 lode claim.

Thence, third course, south eighty-six degrees and fifty-five minutes east six hundred feet to corner No.4 a cedar post six inches square, four feet long, marked 4-779.

Thence, fourth course, north three degrees and five minutes east one thousand five hundred feet to corner No.I, the place of beginning; the survey of the lode claim as above described extending one thousand five hundred feet in length along said Index No.I2 vein or lode.
