GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, That Loran E. Nightingale

has made, constituted and appointed, and by these presents do make, constitute and appoint

the use and benefit

to ask, demand, sue for, recover, collect and receive all such sums of money, debts, duties, accounts, legacies,

owing, payable or belonging to Loran E. Nightingale

and have, use and take all lawful ways and means in his name, or otherwise, for the recovery

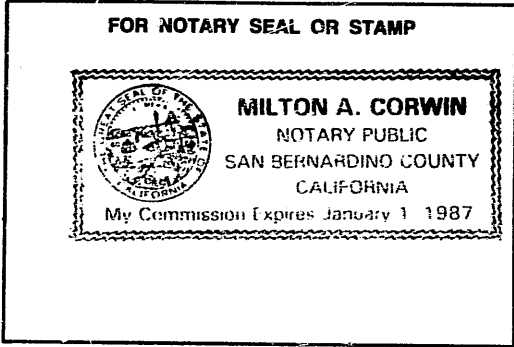
